(i) Immediately following the execution of the Securities Purchase Agreement with the Issuer on July 11, 2021 (the "SPA") (as disclosed in the Form 8-K filed by the Issuer with the Securities and Exchange Commission on July 14, 2021), each of the Reporting Persons may have been deemed to have beneficial ownership of 7,891,827 shares of Common Stock, which consisted of (i) 5,261,218 shares of Common Stock to be issued to Intracoastal at the closing of the transaction contemplated by the SPA and (ii) 2,630,609 shares of Common Stock issuable upon exercise of a warrant to be issued to Intracoastal at the closing of the transaction contemplated by the SPA ("Intracoastal Warrant 1"), and all such shares of Common Stock in the aggregate represent beneficial ownership of approximately 8.7% of the Common Stock to be issued to Intracoastal at the closing of the transaction contemplated by the SPA (1) 83,284,989 shares of Common Stock outstanding prior to the execution of the SPA as reported by the Issuer, plus (2) 5,261,218 shares of Common Stock to be issued to Intracoastal at the closing of the transaction contemplated by the SPA and (3) 2,630,609 shares of Common Stock issuable upon exercise of Intracoastal at the closing of the transaction contemplated by the SPA and (3) 2,630,609 shares of Common Stock issuable upon exercise of Intracoastal Warrant 1. The foregoing excludes (I) 1,700,000 shares of Common Stock issuable upon exercise of a warrant held by Intracoastal ("Intracoastal Warrant 2 contains a blocker provision under which the holder thereof does not have the right to exercise Intracoastal Warrant 2 to the extent

(but only to the extent) that such exercise would result in beneficial ownership by the holder thereof, together with the holder's affiliates, and any other persons acting as a group together with the holder or any of the holder's affiliates, of more than 4.99% of the Common Stock and (II) 14,500 shares of Common Stock issuable upon exercise of a second warrant held by Intracoastal ("Intracoastal Warrant 3") because Intracoastal Warrant 3 contains a blocker provision under which the holder thereof does not have the right to exercise Intracoastal Warrant 3 to the extent (but only to the extent) that such exercise would result in beneficial ownership by the holder thereof, together with the holder's affiliates, and any other persons acting as a group together with the holder or any of the holder's affiliates, and any other persons acting as a group together with the holder or any of the holder's affiliates, of more than 4.99% of the Common Stock. Without such blocker provisions, each of the Reporting Persons may have been deemed to have beneficial ownership of 9,606,327 shares of Common Stock.

(ii) As of the close of business on July 21, 2021, each of the Reporting Persons may have been deemed to have beneficial ownership of 4,345,109 shares of Common Stock, which consisted of (i) 2,630,609 shares of Common Stock issuable upon exercise of Intracoastal Warrant 1, (ii) 1,700,000 shares of Common Stock issuable upon exercise of Intracoastal Warrant 3, and all such shares of Common Stock represented beneficial ownership of approximately 3.3% of the Common Stock, based on (1) 83,284,989 shares of Common Stock outstanding prior to the execution of the SPA as reported by the Issuer, plus (2) 46,029,920 shares of Common Stock in the aggregate issued at the closing of the transaction contemplated by the SPA, (3) 2,630,609 shares of Common Stock issuable upon exercise of Intracoastal Warrant 2 and (5) 14,500 shares of Common Stock issuable upon exercise of Intracoastal Warrant 3.
