Seller acquired Class B Convertible Preferred Shares and a convertible debenture of the issuer as payment in kind from Hillair Capital Advisors LLC on September 7, 2017. In connection with the issuer's November 2018 IPO, on November 14, 2018 the preferred shares and debenture held by HSPL were exchanged with the issuer for units comprised of Common Stock and warrants. Warrants have not been exercised to date.
