The Fund is a private investment vehicle for which Ayrton Capital LLC (the "Investment Manager") serves as the investment manager and Waqas Khatri serves as the managing member of the Investment Manager. The shares consist of (a) 0 ordinary shares plus (b) 1,736,816 warrants that were exercisable as of December 31, 2020 (inclusive of a 4.99% blocker) and 9 non-convertible preferred shares.
